General Instructions

Permit Required

You must have Street Opening Permit in your possession while you work within the Township right-of-way where such work involves the following:

1. Construction or alteration of a driveway or local road
2. Installation or replacement of utility facilities or other structures
3. Adjusting street slope

Application Form

Applications for driveway, local roads or other structures must be submitted in the name of the owners of the property.

Applications for utility facilities must be submitted in the name of the owner or operator of the facility.

Complete all items on the face of this form. Describe in detail what work you intend to do, how you intend to perform the work and the materials you intend to use.

To avoid work delays, submit your application to the Township of Robinson at least 30 days prior to the anticipated start of work.

This application form must be used to apply for a change or time extension to the issued Permit, or to apply for an Emergency Permit Card. An application for time extension must be applied for prior to the permit's expiration date.

Plans

Submit two completed sets of detailed plans of good quality with your application. The plans must clearly illustrate the location and pertinent dimensions of both the proposed installation(s) and related street features.

Fee

Submit two completed sets of detailed plans of good quality with your application.

This permit is issued in accordance with Robinson Township, Washington County Zoning Ordinance. The Permit holder agrees to abide by the regulations established by the Townships Zoning Ordinance or Robinson Township has the right to revoke the permit.
